INTRODUCTION

Wantaim ol niupela tingting na pasin bilong wok, Ricegrowers Limited, wantaim ol bisnis han bilong em na ol narapela wan-bisnis (“**SunRice Grup**”, “**yumi**”, “**bilong yumi**” o “**mipela**”), isave kamapim gutpela na helti kaikai we ol kastoma isave hamamas long em long olgeta hap insait long wol.

Olsem wanelo bisnis long wok bilong rais insait long wol, SunRice Grup iluksave long ol gutpela pasin bilong wok we kampani isave bihainim, wantaim tu pasin bilong bihainim Lo na em igat bikpela komitment long bihainim ol stretpela pasin bilong wok. Sapos bisnis ino bihainim ol dispela stretpela pasin, em iken lusim bikpela moni long ol fine o kisim bikpela mekim save long han bilong Lo, lusim wok bisnis na bungim ol narapela kain ol hevi tu. Moa yet, bikpela astingting em long soim gutpela na stretpela pasin bilong wok bisnis taim yumi wok wantaim ol kastoma, saplaia, konsuma, wokman/meri na tu komuniti.

1 Polisi Statement

- 1.1 SunRice Grup isanap strong long ‘zero tolerance’ polisi bilong em long lukim olsem imas nogat pasin giaman o stil o korupsen. Mipela bai givim bikpela mekim save long olgeta kain pasin or tingting bilong ol man/meri husait igat laik long wokim pasin giaman o stil o igat tingting long halivim ol lain laik mekim ol kainkain rong pasin.
- 1.2 Pasin bilong igat ‘zero tolerance’ imas stap long olgeta wan-bisnis, o ol lain husait iwok bisnis wantaim o iwokim bisnis bilong Sunrice Grup.

2 Han Bilong Dispela Polisi [Scope]

- 2.1 Dispela Anti-Bribery na Corruption Policy (“**ABC Policy**”) ikaramapim olgetea direkta, wokman/meri na ol wok contrak bilong SunRice Grup, ol kampani na tu SunRice, CopRice, Australian Grain Storage (AGS), Riviana, SunFoods, Solrice, Aqaba Processing Company (APC), Rice Research Australia Pty Ltd (RRAPL) na Trukai, maski yu long Australia o long narapela kantri (we polisi ikolim olsem “**yu**” or “**bilong yupela**”).
- 2.2 Em ikarapim tu olgeta ol narapela ol bisnis, arasait long kampani, husait isave wokim wok bilong SunRice Grup, kain olsem ol distributa, agent na ol bisnis patna. SunRice Grup ilaikim olgeta ol bisnis, arasait long kampani, husait SunRice Grup isave wok bung wantaim, ol tu mas wok bihainim ABC Polisi na tu ol stretpela wok pasin bilong SunRice Grup.

3 Astingting

- 3.1 Astingting bilong dispela ABC Polisi em long:
 - (a) Halivim yu long save long ol gutpela astingting na komitmen bilong SunRice Grup long stopim o daonim pasin bilong giaman na pasin korupsen; na
 - (b) Lukautim yu long bihainim stret ol toktok insait long Anti-Bribery & Corruption polisi bilong SunRice Grup.
- 3.2 ABC Polisi em wanelo han bilong bikpela komitment we SunRice Grup igat long lukim olsem yumi mas wokim wok bisnis bihainim ol stretpela pasin insait long wol.

4 Tok Klia

Bribery: Transparency International itok klia long bribery olsem ‘Pasin bilong givim, tok promis o kisim samting we ino bihainim gutpela pasin o tingting. Long kisim/givim ol samting ol man/meri save usim - ol kain samting olsem present, dinau moni o ol narapela ol samting long hamamasim ol yet o ol narapela lain.

Corruption: Transparency International itok klia long korupsen olsem ‘Pasin bilong paolim or bagarapim pawa wanpela igat long em long hamamasim ol yet.

5 OI Lo

- 5.1 SunRice Grup igat bikpela komitmen long bihainim olgeta Lo aninit long Anti-Bribery & Corruption polisi long olgeta hap em iwokim o ronim bisnis long em.
- 5.2 OI bikpela Lo karamapim pasin bilong stil na giaman o korupsen:
 - (a) United States’ Foreign Corrupt Practices Act 1977;
 - (b) United Kingdom’s Bribery Act 2010;
 - (c) Chapter 4, Division 70 bilong Australian Criminal Code Act 1995 (Cth): na
 - (d) OI narapela ol Lo we ikaramapim anti-bribery long ol kantri we SunRice Grup istap long em na SunRice Grup mas bihainim ol dispela ol Lo.

6 Pasin bilong Harim/Bihainim Tok

- 6.1 General Counsel bilong SunRice Grup bai go pas long ABC Polisi.
- 6.2 Wanwan menija igat wok long lukautim ol yet na ol ripot bilong ol na mas lukim olsem olgeta wokman/meri mas bihainim ABC Polisi na SunRice Grup Anti-Bribery na Anti-Corruption na tu ol toktok istap insait long ol narapela wankain polisi, long Seksen 8 lo tamblo, (bungim olgeta long kamapim “ABC Policies”)
- 6.3 Yu bihainim gut na lukim olsem olgeta wokman imas bihainim Polisi na lukim olsem training mas kamap. Yu mas kisim save na bihainim gut ol ABC Polisi na bihainim ol rot bilong putim ripot we ABC Polisi itok klia long em. Yu imas skelim gut na ripotim ol rong pasin, o ol pasin uting em ino stret aninit long Seksen 21, long tamblo.
- 6.4 Wanwan taim bai igat sekim o audit long ol ABC Polisi, long sekim sapos ol wokman ibihainim toktok insait long polisi.

7 Treining, Awareness na Implementation

- 7.1 Menijment long olgeta hap long kampani mas wok strong long skulim ol wokman bilong ol long dispela ABC Polisi, na ol imas stretim o putim sampela ol rot long halivim ol wokman long ol bai bihainim stret ol ABC Polisi.
- 7.2 Olgeta wokman bilong Sunrice Grup, narapla han o wan-bisnis, saplaia, kontreksa na bisnis patra bilong SunRice Grup mas save long tambu bilong Sunrice Grup, we itok tambu long pasin bilong giaman na stil. Toksave imas go long, pastaim long ol istatim wok bisnis bilong ol na long taim ol istatim wok wantaim kampani bihainim tasol Anti-Bribery and Corruption Policy for Dealings with External Parties Policy (“u ken ridim **External Parties Policy**”) bilong SunRice Grup.
- 7.3 Menijment na ol narapela lain igat wok long lukim olsem olgeta wokman mas kisim gutpla skul o treining long save gut long ol ABC Polisi. Dispela bai halivim I halivim ol long wokim wok bilong gut. OI ken wokim sampela moa ol skul o treining long halivim ol wokman, usait wok bilong ol iken bungim birua.
- 7.4 Menijment mas lukluk na skelim sapos ol wokman isave bihainim ol toktok insait long ol ABC Polisi.
- 7.5 Sapos yu laik save moa long wanem ol wok yu mas wokim, yu ken toktok wantaim Kampani Secretary o General Counsel bilong SunRice Grup.

- 8.1 Oi wokman mas ridim na bihainim olgeta toktok stap insait long ABC Policy na tu ol narapela polisi bilong SunRice Grup:

POLICY REQUIREMENTS [Wanem Oi Samting Yu Mas Mekim Long Bihainim Polisi]

9 Bribery em wanem samting?

- 9.1 Bribery em pasin bilong givim samting, giaman long tok promis, givim o kisim samting we bai wokim man o meri long bihainim pasin we ino stret long ai bilong wok bisnis bilong Sunrice Grup, we bai lukim man o meri ikisim halivim long hamamasim em yet.
- 9.2 Oi samting we man ikisim o givim iken moni o ol narapela samting. Kain olsem ol gift o present, halivim igo long wok bilong politik o halivim igo long wok charity, dinau moni, pasin bilong bekim bek halivim, givim wok o bisnis o pasin bilong givim halivim o luksave we igat bikpela pei bilong em.
- 9.3 Maski sapos yu gat laik/tingting long givim bribe, dispela em iminim olsem yu asua pinis long ai bilong Lo.
- 9.4 Bribery ken karamapim sampela long ol dispela samting:
- (a) Man igat tingting long kisim namel man o agent long wokim ofa igo long narapela man iken wokim pasin bribery; o
 - (b) Ofa igo long narapela wanwok o femili, we iluk olsem bribery.

10 OI tambu bilong bribery

- 10.1 Itambu tru long givim, tok promis, peim, kisim, o askim long moni halivim o ol narapela samting. Kain olsem usim bilong ol prais samting:
- (a) Long kisim o halivim bisnis long neim bilong SunRice Grup, o pasin bilong usim stil pasin long neim bilong SunRice Grup na ol wan bisnis bilong Kampani;
 - (b) Long kisim, halivim na stretim ol legal ol wok bisnis long neim bilong SunRice Grup we ino bihainim stretpela pasin;

- (c) Tok oraitim ol ofa, mekim, askim o kisim peiment o ol narapela prais we ino stret, long winim bisnis o giamanim ol man long wokim bisnis disisen; o
 - (d) Usim neim bilong SunRice Grup o ol narapela party long sait bilong kisim win moni.
- 10.2 Sapos wokman o meri ikisim ofa bilong bribery, wokman mas tok nogat na ripotim hariap igo long ofis, we Section 21 itok klia long em.

11 Wei Bilong Peim Moni, Kisim Hait Moni na Pasin Bilong Haitim Stil Moni

- 11.1 Itambu tru long wokman long mekim ‘Facilitation Payments’ o halivim long painim wei bilong stremt o peim moni.
- 11.2 Transparency International itok klia olsem ‘facilitation payment’ (o halivim long painim wei bilong peim moni) em pasin bribery tu, o pasin bilong halivim/stremt, ‘hariapim’ o ‘gris’ moni; we man o meri ipeim long stremt o kisim luksave long Lo long halivim ol.
- 11.3 SunRice Grup ino tok oraitim ol man long makim maus bilong Kampani long wokim dispela kain pasin.
- 11.4 Sapos man o meri imekim dispela pasin long yu, yu mas tok nogat long dispela askim o ofa nay u mas ripotim hariap, we Section 21 itoksav long em.
- 11.5 Em impoten tru long yu mas luksave long wanem samting em pasin bilong “halivim long wokim peimen o givim moni” na wanem em ipasin bilong fos long kisim moni. Helt na seifti bilong yu em namba wan. S a p o s y u k i s i m m o n i p e i m e n t l o n g halivim yu long lukautim helt na seifti bilong yu, yu mas givim ful ripot bilong dispela peiment igo long Kampani Secretary o igo long General Counsel bilong SunRice Grup.
- 11.6 Itambu tu long givim hait moni. Hait moni em moni we man o grup (kain olsem wokman o meri bilong SunRice Grup) igivm igo long namel man (o agent) o maus-man bilong narapela man (kain olsem kastoma bilong SunRice Grup), na dispela namel man o maus-man, ino tokaut long ol bos. Yumi ken tok olsem ol iusim dispela pei moni long halivim ol long wokim wok bisnis.
- 11.7 Pasin bilong haitim stil moni em itambu tu. Pasin bilong haitim stil moni isave kamap taim man o meri o grup ihaitim sampela rot ol man isave usim long kisim moni. Bihain ol isave giaman olsem dispela moni em kamap long stretpela rot.

12 Public na Gavman Opisa

- 12.1 SunRice Grup itambu long muvrim o givim ol samting (we igat bikpela pei bilong em) igo long Public Opisa, insait long kantri o long narapela kantri, sapos em igat hait tingting long kisim o holim passim bisnis o long kisim win moni o ol narapela samting long halivim em yet.
- 12.2 ‘Anything of value’ o ol samting we igat bikpela pei bilong em, ikaramapim ol kain samting olsem moni o ol narapela samting we iwankain olsem moni na tu diskaunt, ol prais, usim bilong ol material, o masin samting, entertainment, dring, kaikai, trengt, haus na tok promis bilong kisim ol gutpela samting long bihain taim.

12.3 Example (o tok bokis) bilong Public Opisa:

- (a) Ol opisa bilong gavman dipatment na ol gavman han (o agency);
- (b) Ol kampani we State ibosim o ronim;
- (c) Ol publik International Organisation; na
- (d) Ol memba bilong royal famili.

- 12.4 Dispela tambu ikaramapim tu ol man/meri usait ibin wok wantaim Gavman o long Pablik Opis na ol femili bilong ol politisen.
- 12.5 Sapos yu save olsem igat sampela kain wok iwok long kamap namel long ol pablik opisa, insait o arasait long kantri, yu mas toksave hariap igo long Generol Menija o ol narapela lain, we Seksen 21 itok klia long em, long kisim moa klia tingting o toksave.

13 Halivim Bilong Politiks

- 13.1 Ol wok bilong ol politisen long nau o bihain taim, politikol pati na ol politikol grup.
- 13.2 Ol 'contributions' o moni halivim:
 - (a) Cash moni halivim;
 - (b) Ol kain gift o prais olsem propeti samting o sevis; na
 - (c) Advetisim o ol promosen we itok oraitim politikol pati.
- 13.3 SunRice Grup iken tok oraitim doneisen o givim halivim igo long ol politikol pati, tasol em imas bihainim ol stretpela pasin bilong Lo na tu ol toktok aninit long polisi bilong Working With Governments and Political Contributions and Activities na dispela ABC Polisi.
- 13.4 Halivim igo long politiks mas noken kamap long bisnis unit o long level bilong divisen. Ol Bod of Direkta bilong Ricegrowers Limited imas tok oraitim pastem olgeta halivim we bai go long ol politisen, bihainim olgeta stretpela rot aninit long polisi bilong Working with Governments and Political Contributions and Activities. Wanem kain halivim we ol politisen ikisim mas kamap ples klia, bihainim ol Lo na imas gat ripot bilong em istap long moni buk bilong Kampani.
- 13.5 Sapos halivim istap antap long mak bilong Federal Lo, ripot mas igo long Australian Electoral Commission long wanwan year bai ol iputim aut long website.

14 Wok Bilong Ol Politiks

- 14.1 SunRice Grup igat polisi long bihainim olgeta local, state, federal na ol Lo bilong ol narapela kantri, long sait bilong givim halivim igo long wok politiks. Tasol SunRice Grup igat rait long tokaut long sanap bilong em long ol impoten samting olsem ol politikol kendidet, ol maus-man/meri na ol narapela ol gavman opisa na ol narapela politikol grup.
- 14.2 Sapos wokman ilaike wokim ol politik wok arasait long Kampani taim, ol mas lukaut gut. Ol wok politik bilong ol mas noken luk olsem ol iwok long wokim wok, makim SunRice Grup.

15 Donesen na Halivim

- 15.1 SunRice Grup igat bikpela komitment long halivim ol komuniti insait long wanem hap em istap long em. Ol wok bilong SunRice Grup itok klia long dispela ol wok komitment bilong Kampani. Tasol em impotent tu long lukim olsem ol wok-hat bilong SunRice Grup imas bihainim ol stretpela rot, aninit long Lo, na ino bilong hamamasim tingting bilong ol wanwan man.
- 15.2 Olgeta donesen bilong wok charity na halivim mas kamap, bihainim olgeta toktok insait long Donations Polisi bilong SunRice Grup.
- 15.3 Long sampela kantri, igat ol lain usait isave usim wok cheriti long hait na wokim pasin birbery. Yu mas lukaut gut long lukim olsem olgeta donesen bilong wok cheriti mas go long wok we ol imakim long em.

16 Present na Entertainment

- 16.1 Oi gift o present na entertainment (o pasin bilong hamamasim wanpla/narapla) iken kam aninit long pasin bribery tu sapos astingting bilong givim o kisim ol dispela samting ino bihainim stretpela rot o igat hait tingting long winim bisnis we bai hamamasim o halivim ol yet.
- 16.2 Pasin bilong givim bisnis prais o gift na wokim ol hamamas bung bilong Kampani ino save wankain long wanwan kantri, rejen na ol wok ples. Wanem samting we iluk orait long wanpela hap bai nonap luk gut long ai bilong ol lain long narapela hap. Olsem na ol opisa mas lulkuk gut na skelim dispela ol pasin.
- 16.3 Igutpela moa sapos ol present o entertainment we ol wokman bilong SunRice Grup igivim o kisim, ino gat astingting bilong kamapim illegal bisnis o long hamamasim ol liklik lain. Givim o kisim bilong ol present na entertainment imas kamap, bihainim olgeta toktok aninit long Gifts, Benefits na Hospitality Polisi bilong SunRice Grup.

17 External Parties, including Distributors and Agents

[Ol arasait lain na tu distribute na namel man]

- 17.1 Sapos wanpela Kampani bilong SunRice Grup ilaik kisim ol arasait lain (or external party) long markim SunRice Grup na mekim wok bilong Kampani, emi impoten tru long imas gat kontrol we bai halivim ol arasait lain (or external party) long wokim wok bilong SunRice Grup stret. Ol arasait lain (o external parties) em ol agent, distributa, namel man, saplaia, purchaser o kontrekt.
- 17.2 Olgeta wok bilong ol lain arasait (external parties) mas bihainim stret olgeta toktok o Lo aninit long External Parties Polisi. An init long agreement long wok bisnis wantaim SunRice Group, wanwan arasait lain (or external party) imas tok orait long bihainim External Parties Polisi na dispela ABC Polisi bilong SunRice Grup.
- 17.3 Oi wok lain long arasait (external parties) usat iken bagarapim SunRice Grup, aninit long ol Anti-Bribery Lo, em ol lain usat isave wok long ol developing kantri o ol kantri usait ekonomi bilong ol iwok long kam antap (kain olsem planti long ol Middle East na Pacific kantri), o ol lain usat isave paitim tok long stretim bisnis o moni wantaim ol publik o praivet sekta, makim maus bilong SunRice Grup long olgeta kantri (ol kain wok olsem bid long tender, paitim tok long givim wok contrak, stretim bilong ol lease o license o halivim bilong transpot (kar) o clearance sevis bilong Customs).

- 19.3 Sapos igat tingting long wok bung long kamapim joint venture, ol arasait lain (or external party) mas bihainim olgeta toktok insait long External Parties Polisi. Dispela imimin olsem ol arasait lain (or external party) mas pulamapim ABC Due Diligence Profile long Schedule 2 bilong External Parties Polisi pastaim long ol igo insait long statim wok contrak. Sapos igat sampela rong ol lain ibungim long ABC Due Diligence Profile, ol wokman mas ripotim hariap igo long General Counsel bilong SunRice Grup. Oi contrak wantaim ol joint venture patna mas igat tu wanem ol samting SunRice Grup ilaikim, aninit long ol toktok insait long ABC na External Parties Polisi.
- 19.4 Usat ol opisa bilong SunRice Grup usat isave wok wantaim joint venture patna mas putim ai gut long ol paol pasin bilong wok long ol narapela lain na tok aut long em.
- 19.5 Long sait bilong baim o kisim bilong bisnis, SunRice Grup mas lulkuk na putim gut ol ripot bilong ol wok

painim aut long anti-bribery, long wanem kain ol bungim bilong bisnis (merger) o baim bilong bisnis, pastaim long tupla patna kampani itok oraitim wok contrak.

Olgeta pepa wok tu mas stret .Man ken go long karabus, aninit long criminal Lo bilong Australia o ol narapela Lo bilong ol kantri we SunRice Grup istap long em, sapos ol pepa wok bilong moni ino stret.
- 20.2 Nogat wanpla ripot bilong moni mas stap arasait long moni buk.
- 20.3 Olgeta moni peiment ikam long opisa bilong SunRice Grup, wantaim tu ol present na entertainment, mas stap insait long moni ripot (expense report) na dispela ripot mas kisim tok orait bihianim tasol Expense Polisi.
- 20.4 General Counsel bilong SunRice Grup bai registerim olgeta present na entertainment, d o n e s e n i g o l o n g w o k politik na cheriti, sponsasip, ol arasait wokman (external parties) na ol narapela infomesen, we ilukim wok bilong SunRice Grup insait long wok politiks. Dispela register bai go long Corporate Management Team, olsem ripot, insait long wanwan quota, na igo long Finance na Audit Komiti bihain long olgeta tupela yia.
