Communication with neighbours and community

Where a pollutant may impact neighbours, the responsible person for the facility will make contact with neighbours are fully informed of the situation. The Area Supervisor will provide regular updates (based on the seriousness of the incident) until the incident and clean-up has been completed.

Where a pollutant may impact the greater community this process will be managed by appropriate emergency services in consultation with the General Manager of the facility ensuring all relevant authorities have been notified.

Neighbours will be notified to each location to inform each home/business to the type of pollutant and emergency. A list of contacts will be provided at this time to keep communication lines open during the incident.
